Agenda Item	Notes
Welcome and Roll Call	Dr. Colmorgen, a member of the DHMIC, welcomed members and facilitated the meeting with Liddy Garcia-Bunuel.
Approval of August 20, 2025 Meeting Minutes	Dr. Colmorgen asked for a motion to approve the August 20, 2025, Minutes. Michelle Statham made a motion to approve. Dara Hall seconded. Minutes were approved.
Housing Workgroup Updates	Ana informed committee members that the housing workgroup met in person on September 23, 2025, at Madern Maturity Center to design the Housing Pilot Program for Pregnant Women. Workgroup members were divided into two groups to identify the target population, eligibility, referral and access pathway, services and housing stability support, as well as metrics and evaluation. Liddy added that this program would provide housing vouchers and support to 20 pregnant women in Delaware for 24 months. MCOs would provide case management and care management, and DPH would be the gatekeeper in charge of oversight and purchase of the vouchers. • Dr. Colmorgen asked if the workgroup is looking at the conditions of the housing units, as many of his clients live in terrible conditions. Michelle Statham informed the committee that under the SRAP program, inspectors look for mold, electrical outlets, easements, safety, and noted that if the unit passes initial inspection, DHSS does not go back again until recertification a year later unless the resident contacts DHSA. • Rebecca Sax asked who would be working with individuals who were not initially part of Medicaid, as a housing coordinator would be critical for the program. Liddy noted that this is something that the workgroup started discussing, and it will be incorporated in the design of the program. • Donald Farrell (Public) asked committee members to consider that landlords take advantage of individuals with vouchers and noted the importance of including lead inspection to protect the women who are enrolled in the program. • Adriana Riveros-Sosa (Public) asked if vouchers expire after they are provided to the client. Michelle Statham noted participants have 60 days initially to look for housing, and DSHA extends that to up to 120 days to find housing. HMA presented the timeline below and asked for approval from the committee to have a virtual vote on the pilot program document on October 30, 2025.

	 Liddy reminded members that Co-chairs met with Social Contract to develop a strategy for housing recommendations for pregnant women, focusing on securing TANF surplus funding and vouchers. She added that the timeline is important as Delaware has a new Secretary of Health and Social Services as well as a new Director of Social Services. SDOH Committee members agreed. ACTION ITEM: SDOH Committee members to review the draft SRAP Housing pilot program description and give feedback to Ana by email based on above timeline.
Updates from other committees and DPQC	Well Women Committee continues to work on video vignettes through the Her Story 2.0 Workgroup to document women's pregnancy experiences. The Data Committee is focused on access to early prenatal care and has had a series of meetings with multiple presenters. Dr. Colmorgen gave an update on the DPQC and the work of the Maternal Health Task Force, which is developing a 5-year strategic plan focused on supporting pregnant and postpartum women with substance use disorder, with five peer support doulas recently hired and trained through Impact Life to provide support antenatally, during labor and delivery, and through 12 months postpartum. - Rebecca asked if the programs were addressing black women, given the disparities. Dr. Colmorgen indicated it covers all women with SUD. - Dr. Colmorgen mentioned he attended an AMA webinar on ACEs that explained some problems of moms interacting with providers and the importance of building relationships to reduce inequities.
